Empanelment of Standing Counsel/Panel Counsel(s) to represent, Indira Gandhi National Tribal University, Amarkantak, M.P. (IGNTU) before Supreme Court/High Court/ other Judicial bodies

1. Empanelment of Standing Counsel/Panel Counsel(s)

The IGNTU, a Central University and an autonomous body proposes to engage Standing Counsel(s)/Panel Counsel(s) to represent the University before Supreme Courts, High Court of Jabalpur and other judicial bodies. The interested Counsels/Law companies/Firms which are desirous to be considered for empanelment and have adequate experience in dealing with legal matters pertaining to academics/ education/ autonomous bodies may apply along with detailed Bio-data/Curriculum Vitae with special emphasis on relevant experience to the Registrar, *Indira Gandhi National Tribal University, Village-Lalpur, Amarkantak, District-Anuppur (M.P.)-484887* within **two weeks** from the date of uploading of this advertisement on the University website i.e. www.igntu.ac.in

The Counsels engaged by University will fall into two categories viz:-

(a) Standing Counsel(s)

(b) Panel Counsel(s)

Qualification for each category of Counsels will be as under:-

A. Standing Counsel: In order to be eligible for appointment as Standing Counsel, a person should:

1. Be enrolled/registered as an advocate with the Supreme Court/ High Court.
2. Have a minimum experience of **ten years** of handling Civil/ Criminal/ service matter cases. Preference will be given to the counsels who have dealt earlier with matters pertaining to academic/education institutions and statutory bodies.

B. Panel counsel: In order to be eligible for appointment as panel counsel, the person should:

- i. Be enrolled/registered as an advocate with the Supreme Court / High Court.
- ii. Have a minimum, relevant experience of **five years** of handling Civil/Criminal/service matter cases. Preference will be given to the counsels who

have dealt earlier with matters pertaining to academic/education institutions and statutory bodies.

Duties of the Counsel

The counsel shall perform the following duties:

1. Represent IGNTU before Supreme Court and High Court of Jabalpur and other judicial bodies;
2. Provide legal advice to University on civil, criminal, service and such other matters arising in the course of administration of University as are referred to him / her including.
 - (a) Examination and drafting of legal documents;
 - (b) Drafting of applications, petitions etc., to be filed in various courts of law;
 - (c) Prompt removal/curing of defects in appeal/petitions filed; as may be pointed out by the registry;
3. Apply for the copy of judgment from the court in cases attended by him/her and supply the copy of judicial pronouncement at the earliest but not later than 10 days from the date of order (excluding the time taken by the court in preparation of the copy);
4. If required, render all assistance to Special or Senior Counsel/engaged in a particular case before the Supreme Court/High Courts and other judicial bodies;
5. Keep University informed and updated on all important developments in the designated cases, date of hearing, order of the Court on the date of its pronouncement, supplying copy of judgment etc.
6. Furnish monthly statement about the cases represented by him/her before the Supreme Court or High court or any other authority and their outcomes.
7. Perform such other duties of legal nature which may be assigned to him/her by University.
8. When any case attended to by him/her is decided against the University, give considered opinion regarding the advisability of filing an appeal from such a decision not later than 5 working days of the order.

General instructions

- a) The Advocate shall not advise any party or accept any case against the University in which he/she has appeared or is likely to be called upon to

appear for or advice which is likely to affect or lead to litigation against the University.

- b) If the Advocate happens to be a partner of a firm of lawyers or solicitors, it shall be incumbent upon the firm not to take up any case against the University in any court of Law/Tribunal/Commission or any case arising out of those cases e.g. appeals and revisions;
- c) Effective Hearing means a hearing in which either one or more parties involved in the case are heard by the Court/Tribunal/Commission on the facts or law of the case. If the case is mentioned by the other side and adjourned or only when directions are given or only judgment is delivered by the Court/Tribunal/Commission, the same shall be a non-effective hearing.
- d) In cases where on the request of Ministry of HRD/UGC interests of UOI have also to be protected, no extra fees shall be paid to the advocate to watch and safeguard the interests of Ministry of HRD/UGC or UOI.

Right to Private Practice

The Counsel will have the right of private practice, which should not however, interfere with the efficient discharge of work of University but he/she shall not advise, holds briefs or appeal against University before any authority, tribunal or court of law.

If the counsel happens to be a partner in a firm of lawyers or solicitors, it will be incumbent on the firm, not to take up any case against University in any court of law or;

Any other case arising in the other courts out of cases pertaining to University e.g. appeals and revision in the High Court or the Supreme Court

Termination of appointment / resignation

The University reserves the right to terminate the appointment/empanelment of a counsel with one month's notice in writing without assigning any reason. The counsel may also resign from University by serving one month's notice.

The University is free to engage any advocate of its own choice and an empanelled Advocate shall make no claim that he/she alone should be entrusted with University legal matters (s).

Fees for standing counsel and panel advocates in Supreme Court / High Court/ Tribunals / Commissions, etc.

1	Fee for appearance in Supreme Court	Rs.9000/- per case per day (for effective hearing); Rs.1000/- per case per day (for non effective hearing, subject to a maximum of 5 hearings)
2	Fee for appearance in High Court	Rs.4000/- per case per day (for effective hearing); Rs.1000/- per case per day (for Non effective hearing, subject to a maximum of 5 hearing)
3	Fee of appearance in Tribunals/Commissions	Rs.3000/- per case per day (for effective hearing); Rs.1000/- per case per day (for Non effective hearing, subject to a maximum of 5 hearing)
4	Fee for appearance in District courts/ Subordinate courts	Rs.2500/- per case per day (for effective hearing); Rs.1000/- per case per day (for Non effective hearing, subject to a maximum of 5 hearing)
5	Fee for drafting SLP/ Writ Petition/Transfer Petition /Counter Affidavit	Rs.5000/-
6	Fee for drafting additional Affidavit/ miscellaneous applications etc.	Rs.4000/-
7	Fee for legal opinion	Rs.4000/-
8	Fee for filling appeals (revision/review) on behalf of University.	Rs.6000/- per case
9	Clerkage	10% (no clerkage will be paid on simple adjournment)
10	Miscellaneous charges	As per actual#
11	Similar/Identical Case	where in two or more case involve substantially identical question of law or facts and where the main difference is in the name, address of the parties concerned, amount of money involved, etc., and/or where common or identical judgments are delivered, irrespective of the fact that all the cases are heard together or not, the counsel/advocate shall be paid the full amount in the main case and Rs.250/- per case per effective hearing for each of the connected case(s). SLP/petitions of appeal arising out of one common judgment or order will be considered as one case, if they are heard together;
