TERMS AND CONDITIONS OF THE TENDER

1. Tender Applicant should quote the price inclusive of machinery supply, installation, commencement, and maintenance (in all respect) for one year and operation six months (inclusive of manpower cost, all taxes etc.).
2. The tender awardee will receive 80 percent of the payment after successful supply, installation and commencement of the operation of the plant and 10 percent of the amount will be released by the university after six months of successful operation of the plant and remaining 10 percent after one year.
3. He/She is also required to obtain a performance satisfaction certificate from the LBI Coordinator and Project Investigator before release of the payment.
4. After successful running the plant for six months and maintaining the plan for one year the tender awardee will hand over the plant to IGNTU in completely running condition in all respect along with all kind of fixed, durable items/assets of the plant.
5. University will bear the raw material, electricity and water charges and the ownership on the produce of plant will be of University and university will develop a mechanism for its selling and distribution. Tender awardee will not be entitled for any monetary benefit outside for the work mentioned in the tender document.
6. Tender awardee is required to run the plant successfully for six months and maintain it for one year before handling over it to the University and is required to guide, demonstrate and produce various items in the plant for six months.
7. Tender awardee has no right on the selling revenue of the products manufactured in the plant.
8. Partial /Conditional/Incomplete Tender Applications are liable to be rejected by concerned Committee of Indira Gandhi National Tribal University, Lalpur - Podki, Amarkantak, M.P. , PIN-484887.
9. Any Tender applicant cannot sub-let this tender to some other person/firm/company/agency etc. may be in part or full even at the same cost in any condition whatsoever it may be.
10. All tender applicants have to completely fill Technical Bid and Financial Bid both. Financial Bid of only those bidders will be opened who will qualify in Technical Bid.

- a.
